Date: July 18-19, 2022 Course: Southern Pines Golf Club

Format: Two rounds of 18 holes stroke play. Maximum handicap allocation 36

**Eligibility:** Open to all amateur women golfers 16 years of age and older as of July 18, 2022 with a World Handicap GHIN index. No residency requirement.

**Benefit:** This event raises funds for Friend to Friend, a Moore County non-profit organization whose mission is to help survivors of domestic violence and sexual assault rebuild their lives.

**Entry Fee:** \$160 per player. The entry fee includes a \$20 donation for Friend to Friend, green fees for two days of play, cart, range balls, prizes and Tuesday awards with box lunch.

**Practice Round:** An optional practice round is available to all players with an accepted entry. To schedule, call after July 1<sup>st</sup>. The rate is \$40.

## Divisions /Flights: Players are placed in flights based on handicap.

The Championship trophy is awarded to the player with the over-all low gross score. Friendship trophy is awarded to the player with the over-all low net score. A tie for low gross is settled with on-course playoff. Over-all low net settled with score card play-off as approved by the USGA.

**Field:** There is a maximum of 78 in the field. The field will be set based on order of entry received. The tournament committee will be heavily involved with the US Women's Open. Applications are available for entry on June 1, 2022. However, no applications will be processed until June 6<sup>th</sup> after the close of the US Women's Open. On June 6<sup>th</sup>, the applications will be drawn by lot for processing.

**Prizes:** The MCWA Gross Champion's name will be added to the tournament trophy housed in the Tufts Archive. A trophy will be awarded to the overall Champion and to the Friendship Low Net player with the lowest two day score. Additional prizes will be awarded in each flight.

Entry Fee is \$160. An additional contribution to Friend to Friend is welcome and may be added to the entry fee. Make checks payable to 'MCWA'. Mail with the completed entry form to: Betsey Mitchell, MCWA, 63 Greyabbey Dr, Pinehurst, NC 28374. Application Deadline: Delivered by July 8, 2022

**Refunds:** No refunds will be issued to withdrawals after July 8. Refund checks, minus a \$20 contribution to Friend to Friend (and any additional donation included with the applicant's entry), will be mailed by June 30th for withdrawals received by June 15th and by July 30th for withdrawals received between June 15th and July 8th.
